Estt. Order No. 22/2021

As per the findings of DPC for the year 2022 for promotion of Lower Division Clerk to the grade of Sub-Inspector held in the office of Narcotics Commissioner on 07-09-2021, the following LDC's are hereby promoted to the grade of Sub-Inspector (Group 'C') in Level-4 of pay matrix Rs. 25500/- {pre-revised scale PB-4 Rs.5200-20200+2400/- (Grade Pay) with effect from the date they assume charge of the higher post, **not before 01-01-2022.**

1. The officials should note that:
 - (a) If they do not accept the offer of promotion within **10 days** of issue of order and if fail to report for duty at their respective place of posting, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of Sub-Inspector, for a period of one year.
 - (b) Their seniority will be reckoned on the basis of panel drawn by DPC for the year 2022 held on 07.09.2021.
 - (c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.
2. The promotion, in the higher grade, in respect of the officials shall take effect from the date they take over the charge of higher post, **not before 01-01-2022.**
3. The following officers being promoted through this Order shall assume the charge of Sub-Inspector on in-situ ('as is where is') basis till regular postings are made with the approval of the Competent Authority:
