As per the findings of the Supplementary DPC for the year 2023 for promotion from Inspector to the post of Superintendent/DOO held in the office of Narcotics Commissioner on 16.08.2023, the following Inspector are hereby promoted to the post of Superintendent/DOO (Group 'B' Gazetted) in Level-8 of pay matrix Rs. 47,600 to 1,51,100 with effect from the date they assume charge of the higher post.

1. The officials should note that:

(a) If they do not accept the offer of promotion within 10 days of issue of order and fail to report for duty at their respective place, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of Superintendent/DOO, for a period of one year.

(b) Their seniority will be reckoned on the basis of panel drawn by the above mentioned DPC for year 2023.

(c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

2. The promotion, in the higher grade, in respect of the officials shall take effect from the date they take over the charge of higher post.

3. Their regular posting will be decided in due course. Till then they shall assume the charge of the promotional post on in situ (as is where is) basis.

4. The above officers may join the new assignment immediately. A compliance report on the same should be sent to the undersigned immediately.
