Estt. Order No 38/2023

As per the findings of the Supplementary DPC for the year 2023 for promotion from Inspector to the post of Superintendent/DOO held in the office of Narcotics Commissioner on 16.08.2023, the following Inspector is hereby promoted to the post of Superintendent/DOO (Group 'B' Gazetted) in Level-8 of pay matrix Rs. 47,600 to 1,51,100 with effect from **01.10.2023** or the date he assumes charge of the higher post.

1. The official should note that:

(a) If he does not accept the offer of promotion within 10 days of issuance of order and fail to report for duty at his respective place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of Superintendent/DOO, for a period of one year.

(b) his seniority will be reckoned on the basis of panel drawn by the above mentioned DPC for year 2023.

(c) he is required to submit within one month of promotion, his option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the official has been granted benefit of financial upgradation under the ACP/MACP Scheme, his pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

2. The promotion, in the higher grade, in respect of the official shall take effect from the date he takes over the charge of higher post.

3. His regular posting will be decided in due course. Till then he shall assume charge of the promotional post on in situ (as is where is) basis.

4. A compliance report on the same should be sent to the undersigned immediately.


