As per the findings of the review DPC in the grade of Inspector (from UDC/Steno) for the years 2013-14 to 2017-18 held in the office of Narcotics Commissioner on 09.10.2023, the following officials are hereby promoted in the grade of Inspector (Group 'B' Non-Gazetted) in Level-7 of pay matrix Rs. 44,900/- to 1,42,400/- with effect from the date they assume charge of the higher post.

2. Those officers who have retired/expired from the post of UDC/Steno/DOS will be eligible for benefit of notional promotion w.e.f. the date of promotion of their immediate junior in the reviewed panel and fixation of notional pay subject to the fulfillment of following conditions mentioned in DoPT OM F. No. 22011/3/2013-Estt(D) dated 15.11.2018:

- (i) That the officer who is immediate junior to the retired Government servant assumed charge of the higher post on or before the date of Superannuation of the retired Government servant.
- (ii) That the said retired Government servant was clear from vigilance angle on the date of promotion of his immediate junior.
- (iii) a retired Government servant who is considered for notional promotion from the date of promotion of his immediate junior on the recommendation of a review DPC would also be entitled to fixation of pension on the basis of such notional pay.
- (iv) The notional promotion, notional pay fixation and revision of pension shall be further subject to extant rules on promotion, pay fixation and CCS (Pension) Rules, 1972. Actual increase in pension shall be given only from the date of approval of reviewed panel by the competent authority. No arrears shall be paid.

3. Their seniority will be reckoned on the basis of panel drawn by the above mentioned review DPC in the grade of Inspector (from UDC/Steno) for the years 2013-14 to 2017-18 .

4. The officials at 26 to 29 and 34 should note that:

(a) If they do not accept the offer of promotion within 10 days of issue of order and fail to report for duty at their respective place, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of Inspector, for a period of one year.

(b) The promotion, in the higher grade, in respect of the officials shall take effect from the date they take over the charge of higher post.

(c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of

Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

(d) They should note that their promotion is subject to the condition of successful completion of probation period of two years which can be extended, if their performance during the probation period is not found to be satisfactory.

(e). Their regular posting will be decided in due course. Till then they shall assume the charge of the promotional post on in-situ (as is where is) basis.

This issues with the approval of Narcotics Commissioner.
