**Estt. Order No. 53/2023**

As per the findings of the Supplementary DPC for the year 2023 for promotion from Inspector to the post of Superintendent/DOO held in the office of Narcotics Commissioner on 16.08.2023, the following Inspector is hereby promoted to the post of Superintendent/DOO (Group 'B' Gazetted) in Level-8 of pay matrix Rs. 47,600 to 1,51,100/- , on in-situ, with effect from 01.12.2023 or the date she assumes charge of the higher post, whichever is later.

1. The official should note that:

(a) If she does not accept the offer of promotion within 10 days of issue of order and fail to report for duty at their respective place, it will be considered as refusal of promotion and she shall not be given the offer of the promotion to the grade of Superintendent/DOO, for a period of one year.

(b) Her seniority will be reckoned on the basis of panel drawn by the Supplementary DPC for year 2023.

(c) She is required to submit within one month of promotion, her option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27<sup>th</sup> July 2017. However, where the official has been granted benefit of financial upgradation under the ACP/MACP Scheme, her pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

2. Her promotion to the post of Superintendent is subject to the outcome of the decision of the O. A. No. 200/1073/2017 filed by her in the Hon'ble CAT, Jabalpur.

3. The promotion, in the higher grade, in respect of the official shall take effect from 01.12.2023 or the date she takes over the charge of higher post, whichever is later.

4. The above officer may join the new assignment immediately. A compliance report on the same should be sent to the undersigned immediately.
