एजीटी-2026 समिति द्वारा प्रस्तुत सिफारिशों के परिप्रेक्ष्य में तथा माननीय नारकोटिक्स आयुक्त द्वारा उनके अनुमोदन उपरांत, विभिन्न श्रेणियों में निम्नलिखित स्थानांतरण एवं पदस्थापन, तत्काल प्रभाव से एवं आगामी आदेश तक, निम्नानुसार आदेशित किए जाते हैं:-

Consequent upon submission of recommendations by the AGT- 2026 Committee and its acceptance by the Narcotics Commissioner, the following transfer and postings in various grades are hereby ordered with immediate effect and until further orders: -

टिप्पणी:-

1. इन्सिद्द सुपरिन्टेंडेंट्स को तब तक कार्यमुक्त नहीं किया जाएगा और वे अपने नए पदस्थापन का कार्यभार नहीं संभालेंगे जब तक कि इन्सिद्द एसी को CBIC द्वारा जारी पोस्टिंग आदेश के अनुसार कार्यमुक्त न किया जाए।
2. प्रत्येक इकाई के उप नारकोटिक्स आयुक्त, स्थानांतरित अधिकारियों की पदस्थापन फील्ड इकाइयों में स्थल का निर्धारण करेंगे। अधिकारियों के पूर्व पदस्थापन इतिहास को समुचित रूप से ध्यान में रखा जाए तथा पदस्थापन एजीटी नीति में निर्धारित मानकों के अनुसार ही किया जाए। इसके अतिरिक्त, वे अधिकारी जिन्होंने किसी विशेष चार्ज में दो वर्ष या उससे अधिक अवधि पूर्ण कर ली है अथवा किसी स्टेशन पर अपनी निर्धारित अवधि पूरी कर ली है, उन्हें एजीटी नीति में वर्णित कार्यकाल के अनुसार रोटेशन के आधार पर स्थानांतरित किया जाए।
3. उपर्युक्त अधिकारियों को तत्काल प्रभाव से कार्यमुक्त किया जाए। तथापि, जो अधिकारी तोल (Weighment) कार्य में संलग्न हैं, उन्हें उक्त कार्य की पूर्णता के उपरांत ही कार्यमुक्त किया जाएगा। कार्यमुक्ति से पूर्व वे अपना कार्यभार/दस्तावेज/उपकरण आदि विधिवत हस्तांतरित करेंगे। अनुपालन रिपोर्ट अधोहस्ताक्षरी को प्रेषित किया जाए।
4. यह आदेश एजीटी-2026 के संबंध में विभिन्न श्रेणियों में प्राप्त सभी अभ्यावेदनों का निस्तारण करता है। नवीन पदस्थापन स्थल पर कार्यभार ग्रहण किए बिना किसी भी प्रकार के अतिरिक्त अभ्यावेदन पर विचार नहीं किया जाएगा।

यह आदेश नारकोटिक्स आयुक्त की स्वीकृति से जारी किया जाता है।

Note:-

1. The superintendents in-situ will be relieved and take charge of their new place of posting only after the ACs in-situ are relieved consequent upon the posting order issued by CBIC.
2. The Deputy Narcotics Commissioner of each unit will further decide the place of posting of the officers who have been transferred to field units. The history of postings of the officials may be given due consideration and postings may be given strictly according to the norms provided in AGT policy. Further, the officers who have

- completed two years or more in a particular charge or have completed their tenure at a station should be rotated subject to tenures mentioned in the AGT policy.
3. The above officers should be relieved on or before 03.04.2026, Friday. However, the officers engaged in weighment operation shall be relieved after completion of weighment operation.
 4. Before relieving, they shall properly handover the charge/documents/ equipment etc. A compliance report shall be sent to the undersigned.
 5. This order disposes of all the representations in various grades for AGT- 2026. No further representations shall be entertained without joining at new stations.

This issues with the approval of the Narcotics Commissioner.
