Subject: - **Issue of Public Notice with regard to submission of separate applications in "Form-K" for each controlled precursor chemicals as scheduled in Schedule-C of NDPS (RCS) Order, 2013- Reg.**

It has been brought to the notice of the Narcotics Commissioner that some Indian Importer companies are submitting their application in "Form-K" for issue of NOC for import of more than one Controlled Precursor Chemicals as scheduled in Schedule-C appended to the "Narcotics Drugs & Psychotropic Substances (Regulation of Controlled Substances) Order, 2013" which is not in accordance with provision under Para 11 of NDPS (RCS) Order, 2013.

Further, the Narcotics Commissioner has directed henceforth, not to entertain the applications containing more than one controlled precursor chemicals. As per direction of the Narcotics Commissioner, as provided in NDPS (RCS) Order, 2013, each import application should bear only one controlled precursor chemical and for import of another controlled precursor chemical, another separate application in "Form-K" is to be submitted.

Accordingly, in order to streamline the procedure in accordance with the provisions under NDPS (RCS) Order, 2013, a Public Notice has been issued in this regard and same is uploaded on the CBN Official Website www.cbn.nic.in. A copy of the same is also attached herewith for your ready references.

PUBLIC NOTICE

It has been brought to the notice of the undersigned that some Indian Importer companies are submitting their application in "Form-K" for issue of NOC for import of more than one Controlled Precursor Chemicals as scheduled in Schedule-C appended to the "Narcotics Drugs & Psychotropic Substances (Regulation of Controlled Substances) Order, 2013".

This practice of submitting a single application in "Form-K" for issue of NOC for more than one Controlled Precursor Chemicals is not in accordance with provision under Para 11 of NDPS (RCS) Order, 2013. Actually, as per provision under Para 11 of NDPS (RCS) Order, 2013, a single application in "Form-K" is required to be submitted for want of NOC for import of each single controlled precursor chemical. It means, each import application should bear only one controlled precursor chemical and for import of another controlled precursor chemical, another separate application in "Form-K" is to be submitted.

Henceforth, the applications in "Form-K" containing more than one controlled precursor chemicals shall not be entertained. Accordingly, in order to avoid rejection of applications as well as unnecessary delay in processing of the import applications, all the concerned Indian Importer Companies as well as all the stakeholders are hereby advised not to submit application in a single "Form-K" for want of issue of NOC for more than one Controlled Precursor Chemicals as scheduled in Schedule-C.

This Public Notice is being issued in order to streamline the procedure in accordance with the provisions under NDPS (RCS) Order, 2013.
