### TENDER DOCUMENTS

Central Bureau of Narcotics, Kota invites bids on GeM portal for **Auction of seized vehicle, Qty- 09 Nos.** as detailed in the Annexure-I from the Bidders/Parties on "AS IS WHERE IS, WHAT IS" basis subject to the following terms and conditions: -

#### **1. ELIGIBILITY CRITERIA**

Participating bidders shall meet the following qualifying criteria: -


- Bidder shall submit respective documents for each eligibility criteria on GeM portal. Failure to submit the documents shall result in disqualification of the bid.

#### **2. TERMS & CONDITIONS FOR e-AUCTION OF SEIZED VEHICLE BY CENTRAL BUREAU OF NARCOTICS, KOTA: -**

The auction would be held **separately for each vehicle**. The terms and conditions of the sale are as under :-

1. The vehicle will be sold "as is where is, and what is" basis. No complaints whatsoever will be entertained after the bid is submitted and it will be understood that the auction purchaser has fully satisfied himself regarding the Quality, Quantity and Condition of the vehicle before bidding.
2. Before commencement of the auction every intending bidder will have to submit Earnest Money Deposit of Rs. 10,000 /- for heavy vehicles / Rs.5,000/- for LMV / Rs.1,000/- for two wheelers to the auctioning authority in form of Demand Draft in favor of 'DDO, CBN, Kota'. The EMD will be refunded to the unsuccessful bidder after e- Auction.

3. Vehicle may be inspected on any working day between 10.00 AM to 4.00 PM in the premises of Office of the as mentioned in Annexure-I.
4. Full payment shall be paid by successful H1 bidder via Fixed deposit in favour of '**DDO, CBN, Kota payable at Kota, or in Bharat Kosh (as mentioned in Annexure-I)**' within 10 (Ten) days of issuance of Sale order through GeM (confirmation of Sale) failing which the security deposit as deposited by successful bidder will be forfeited.
5. The successful H1 bidder will have to deposit the Goods and service taxes as per reverse charge mechanism. The auctioned vehicle will only be uplifted after submission of GST receipt.
6. Bidders shall ensure that their tender(s), complete in all respects, are submitted online through GeM portal only. Prospective bidders are advised to visit the website <https://gem.gov.in/> regularly before submission of their bids as any further amendments/information will be published on GeM only.
7. The bidder who fails to lift the material even after awarding NOC will be blacklisted by the competent authority and even all the firms of the related bidder will be blacklisted and the name of the concerned person will be communicated to all the government organizations.
8. Bids remain valid for 60 days from the auction closing date. If the 60th day is holiday, validity extends to the next working days.
9. **Central Bureau of Narcotics, Kota** reserves the right to cancel, extend, or modify the auction process at any time. CBN, Kota also has the right to withdraw items from the auction without assigning any reason if deemed necessary.
10. Vehicles must be lifted by the authorized buyer with their own arrangements (like labour and vehicles) within 30 working days of delivery order.
11. H1 bidder shall inform this office for scheduled lifting of auctioned vehicles, 7 days in advance.
12. Delay in lifting beyond 30 days shall incurs 2% per week of the order value.
13. Buyer is responsible for ensuring safety compliance during lifting. Any loss, damage or injury to infrastructure/human within CBN, Pratapgarh and Chittorgarh premises shall be buyer's liability. CBN, Kota is not indemnified against all such claims.
14. CBN will not be responsible for any loss or damage in vehicle after auction.
15. The successful H1 bidder should furnish Identity and Residential address proofs before lifting the vehicle.
16. The courts at Kota will have the jurisdiction to try any matter, dispute or reference between the parties arising out of the contract. It is specifically agreed that no court outside and other the court shall have jurisdiction in the matter
17. Any corrupt act (bribe, commission, influence) leads to immediate termination of bid and blacklisting.
18. Deputy Narcotics Commissioner, CBN, Kota reserve the right to amend or issue addendums to these terms before auction closure.
